## TERMS AND CONDITIONS

All rates are **land only**, double occupancy based on exchange rates as of March 1, 2023.

**TOTAL PRICE \$5750.00\*\* UNTIL APRIL 15, 2023**

Guarantee your reservation with a non-refundable **\$2500.00** deposit. Balance due as follows: **\$2500.00** due June 15, 2023 and balance of **\$750.00** due on or by September 1, 2023.

Once your registration has been received, we will send a purchase confirmation and welcome letter to email address provided. As we get closer to our departure date, we will keep you in the loop about our custom destinations and events and some of the backstories to make every day of your Paris Décor Tour experience extraordinary.

Tour does NOT include:

- \*Airfare from home city to Paris round trip
- \*Any meals except breakfast at the hotel or as noted on itinerary
- \*Any admissions or fees except for those noted on itinerary
- \*Any additional transportation fees outside of those listed
- \*Optional activities, entries & transportation is on you.
- \*Travel and cancellation insurance
- \*Personal expenses
- \*Tips for guides, hotel staff, taxis, etc.
- \*All items of a personal nature, such as telephone calls, laundry, pay TV, hotel mini-bars, etc.
- \*All private excursions not specified in the itinerary
- \*Any public transport, taxi, local bus, rail or flights not specified in the itinerary

**Cancellations** – The deposit is non-refundable. Cancellations 90 days prior to tour date – 50% non-refundable; 30 days prior to tour date – 100% non-refundable. Cancellation within 30 days or less will result in forfeiture of the entire cost of the tour.

**Trip cancellation insurance is strongly advised; medical insurance is required.**

### AIRFARE TO BE PURCHASED INDEPENDENTLY

**Airfare-** Air transportation to and from Paris is the responsibility of the participant. You will need to be in Paris from **Wednesday, September 6, 2023 to Tuesday, September 12, 2023**. Please arrange your flights accordingly. Private transportation to and from Charles de Gaulle Airport to hotel is included. We will provide information on transfers from the airport to our hotel 10 days BEFORE tour departure. **Your passport must be valid for at least 6 months after scheduled date of return.**

**Hotel-** Six nights of accommodation will be provided. A full daily breakfast is included. If you plan on arriving early or extending your stay, we are happy to discuss additional accommodations, please see below.

**Entrance Fees, Tickets, Group Meals-** Admission to all venues, instruction sessions, tours and meals listed on itinerary is included. All other meals are the responsibility of the individual.

**Not Included in the Tour Price-** Passport fees, visa (non-U.S. citizen), personal and/or baggage insurance, excess baggage, meals, tours and entrance fees not specified in the itinerary, all items of a personal nature such as laundry, cleaning, telephone, and beverages. Wine, liquor, soft drinks, tips to porters, drivers and local guides, and any other items not specifically mentioned as included above and listed here.
