**Airfare-** Air transportation to and from Paris is the responsibility of the participant. You will need to be in Paris from Wednesday, January 16th, to Wednesday, January 23, 2012. Please arrange your flights accordingly. Private transportation to and from Charles de Gaulle Airport is included. We will provide information on transfers from the airport to our hotel 10 days BEFORE tour departure.

Your passport has to be valid for at least 6 months after scheduled date of return.

**Hotel-** Seven (7) nights of accommodation will be provided. A full breakfast is included. The single room supplement is

**Entrance Fees, Tickets, Group Meals-** Admission to all venues, instruction sessions, tours and meals listed above is included. All other meals are the responsibility of the individual.
